3. The Superintendent of Police, Thenni, in his letter 4th cited, has stated that the applicant Thiru.M.Sahul Hameed has not come to any adverse notice and not involved in any criminal case during his stay at Thenni District. The Revenue Divisional Officer, Palyakulam, in his letter 3rd cited, has recommended for the inclusion of the name of Thiru.M.Sahul Hameed in the Panel of Engineers.



4. 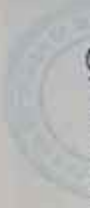
